A SPOTLIGHT ON COLLEGE CLUBS AND SOCIETIES

RED RIBBON CLUB

Red Ribbon Club is a movement started by the Government of India in schools and colleges through which students will spread awareness about HIV / AIDS. The objective of Red Ribbon Club formation in colleges is to encourage peer-to-peer messaging on HIV prevention and to provide a safe space for young people to seek clarifications of their doubts and myths surrounding HIV/AIDS. It aims to instill among students of the college values of charity and community service.

CAREER COUNSELLING AND PLACEMENT CELL

The Career Counselling Cell of a college serves as a vital resource for students as they navigate their academic and professional journeys. It offers personalized guidance, support, and resources to help students make informed decisions about their careers. This cell typically provides services such as aptitude testing, career assessments, resume building workshops, mock interviews, and information sessions on various career paths and industries. NSS

Popular as NSS, this program is conducted by the Ministry of Youth Affairs & Sports. NSS, the scheme was launched in the Gandhi centenary year, 1969 and was aimed at developing the personality of students through community service. The scheme orients the students to community service. The student gets the opportunity to participate in various National / State level programme such as National Integration, Adventure camps, workshops, Youth exhibition, cultural programmes etc. The NSS volunteer gets appropriate weightage if he/she completes 2 years in NSS and gets the certificate.

ROVER AND RANGER

Rover/ Ranger is the senior wing of Scouting and Guiding. It was started by founder of the scouting movement Lord Powell in 1919. Any regular student of the College/ University between the age group of 1625 years can be enlisted as Rover (Boy)/ Ranger (Girl). A unit consists of 24 Rovers called Rover crew and 24 Rangers called ranger team. The purpose of the movement is to contribute towards the development of young people in achieving their full physical, intellectual, social and spiritual potential as an individual and as a community, through several outdoor and community service campaigns. The college is equipped with two smart classrooms to enhance the teaching-learning experience.

ELECTORAL LITERACY CLUB

The Electoral Literacy Club (ELC) is established with the aim of educating and informing students about elections, the electoral process, voter registration, voting patterns, practices, and issues in India.

LITERARY CLUB

College Literary club promises to provide a platform for various literary activities in both English and Hindi medium. The aim of the club is to promote and cultivate a love for literature, language and creative expressions among students. It facilitates discussions on literary works and encourages reading habits among students.

PARENT-TEACHERS ASSOCIATION (PTA)

To encourage community participation in education, Parents-Teachers Association has been established. It helps in better coordination and interaction between parents and teachers for improvement in academic standards and infrastructural facilities. Parents, guardians (who are in blood relation of the students), teachers and head of the institution are members of this association. Parents are advised to attend the meeting of the General House scheduled for August/September so that they may make meaningful contribution to the development of the college.

OLD STUDENT ASSOCIATION (OSA)

OSA is an association of graduates or of former students. It provides a variety of benefits and services the help alumni maintain connections to their educational institution and fellow graduates. The old student's community shares their experience in the outside world, which they face after stepping out of the institution. College is in the process of registering of OSA of the college.

COLLEGE STUDENTS' CENTRAL ASSOCIATION (CSCA)

To encourage student's participation in maintaining proper academic atmosphere, in organizing various cocurricular activities, and to promote opportunities for the development of character, leadership and discipline, the Student's Central Association is constituted every year. Elections are conducted for the posts of four office bearers and class representatives as per the schedule announced by H.P. University every year. Elections/nominations to the CSCA are governed by the rules and regulations prescribed by H.P. University, Shimla from time to time. Other members of CSCA are nominated by the principal in accordance with the CSCA Constitution.

EDUCATIONAL / STUDY TOURS

Educational tours are arranged only for final year students and such tours are allowed only during winter vacation. The routes will be recommended by the concerned committee and approved by the Principal.

- The college will provide limited financial support as permitted under rules.
- Students will have to produce written permission from their parents for joining such tours.
- The college will not recognize any organization other than Central Student Association or Subject Societies as are established by college authorities. Application for educational tours must reach via Convener of Educational Tour Committee.

UNIQUE INITIATIVES

- **Preservation of Cultural Heritage through Music Projects** : In this project, the students create models of Indian musical instruments, Sitar, Tabla, Tanpura, Xylophone and Guitar. The purpose of the project is to combine artistic skills with a technical understanding of musical instruments. Students gain hands-on experience with instrument construction and developed a deeper understanding of the sitar's role in Indian classical music.
- **Preservation of Cultural Heritage of the Region:** It aims to keep alive the traditional songs of the local dialect which are on the verge of extinction, to connect the younger generation with their culture which is getting distanced from their culture, to inculcate a sense of pride and respect towards the local culture. The initiative aims to preserve and promote the Pahari folk culture by engaging students in collecting traditional folk songs from the villagers. This activity promoted the connection between the younger generation and their cultural roots.
- Industry-Academia Collaboration Initiatives: At Government college Barotiwala, we believe in bridging the gap between academic learning and Industry practices through sustained and structured collaboration. Our Industry -academia collaboration initiatives are designed to foster innovations. strengthen the infrastructure, enhance employability and drive mutual growth by integrating academic expertise with real-world industrial experience.

ONLINE LEARNING FACILITIES

The college uses virtual platform for students to strengthen the classroom learning experience and allows students to continue their reading and learning after the class hours and outside the classroom. All the necessary information related to upcoming events, reading material including notes, presentations, videos, assignments, discussion forums, tests and quizzes, grade-book is provided to the students, faculty and staff through this medium

STUDENT EVALUATION

Internal Assessment of students is formulated through home assignments, viva, group discussions, presentations and theatrical representation of ideas.

MENTOR- MENTEE SESSIONS

These sessions are held to analyze the potential of students. It plays an important role to understand the student's mental and emotional phase. The session provides moral support and motivation to the students, directing them to move on the correct path to achieve their goals. Major subject teachers regularly mentor students to support their academic and personal development.

TRAINING STUDENTS FOR PERSONAL INTERVIEW AND PERSONALITY BUILDING

The college provide students with workshops and seminars which help them to enhance their skills, to qualify the personal interview rounds. These sessions help them to identify and apply the questioning techniques to target appropriate competencies.

WORKSHOPS ON LIFE SKILLS

These workshops prepare students to deal with real life struggles and stress, boosting their confidence to overcome the peer pressure.

VALUE ADDED COURSES / ADD ON COURSES

These courses help the students to have a better understanding of leadership and its traits. It gives an insight on how to manage the conflicts in work place & society. This will not only make the students ready but also give a vision to choose entrepreneurship as their career.

SCHOLARSHIPS

A number of Government- sponsored scholarship schemes are available to the eligible and deserving students. Information regarding the dates and eligibility conditions are notified on the Notice Board from time to time. Students are guided about the online application process by the teachers who constitute the Scholarship Committee. The application should be supported by the relevant documents. Eligibility and conditions for the scholarships are detailed on the **National Scholarship Portal**. Students must regularly visit the college website to check the eligibility criteria for registration modalities and important deadlines. Following are some of the scholarship opportunities available under various government schemes:

- 6. Merit Cum Means Scholarship.

The college provides financial assistance to needy students with weak financial backgrounds under the Student Welfare Fund.

LEAVE RULES:

- 1. Application for leave from college should be submitted on the prescribed Leave Application Form. It should be signed by Parents/Guardians. It is compulsory for all students to get their leaves sanctioned before proceeding on leave for whatever reason.
- 2. Teacher teaching major subjects will sanction leave up-to six days which will be finally approved by the principal. After the approval, students should get it signed by all the teachers teaching him/her. Students must retain one photocopy of the approved application and submit the approved original copy of the leave application to the JOA (I. T. In case of sickness, Medical Certificate should be submitted during leave days for office record. Leave for longer duration will be sanctioned by the Principal.

- 3. Leave during House examination will be sanctioned by the principal on the recommendation of the senior tutor.
- 4. A student will not be allowed to avail more than 10 days leave during the entire academic session, except under exceptional circumstances.
- 5. If a student remains absent for 7 days continuously without information, his/her name will be struck off from the rolls of the College.
- 6. Even if a student is on leave, he/she will have to deposit his/her fee as per the scheduled dates decided by the College.
- 7. Re-admission: Students can seek readmission only twice during the session. First readmission will be allowed within 7 days after the name is struck on paying a fine of Rs 100/- and a fine of Rs 200/- will be charged for the second readmission within 5 days after the name is struck off from the rolls.

CODE OF CONDUCT FOR THE STUDENTS

- Ragging in any form is a crime and will lead to heavy fines and even expulsion or other actions as recommended by the Government of India. Each and every student will have to give undertaking (mentioned in the prospectus) not to indulge in ragging of any kind.
- If a student fails to attend 75% of the total lectures delivered in each subject, the University examination roll number shall be detained as per norms.
- Indiscipline in the College campus amounts to striking off the names from the college rolls.
- Wearing of Bonafide Identity Card in the campus and classes is compulsory. The students without Identity Card will not be allowed to enter in the college.
- Damage to the College property would invite a fine double the damage and / or striking off the name from the College rolls.
- Use of mobile phone is strictly prohibited. Any student using cell phone in the class/campus would invite a fine of Rs. 100/- and / or forfeiture of Cell Phone.
- Use of alcohol and drugs is strictly prohibited in the College campus.
- Use of Tobacco products is banned under COPTA 2003 (Cigarette & other Tobacco Products Act,2003). If someone is found using these products, he/she will be penalised under the act.

Students are not allowed to bring/invite outsiders to the college premises.

Note:

In case of any grievance, the students are advised to put it before college Grievance Committee/Principal. If any student approaches to any external authority/media directly, his/her name may be struck off from the college rolls. Students must read the Notice board regularly to get information about instructions/orders issued by the principal from time to time.

LIBRARY RULES

A student can be issued books on the basis of Identity card for 28 days

only. After due date of book, fine would be charged Re. 1/- per day, per Book.

UNDER GRADUATE PROGRAMMES (ANNUAL SYSTEM)

The college provides UNDERGRADUATE PROGRAMME in two streams: **1) Bachelor of Arts**

2) Bachelor of Commerce

The programmes are being run in accordance with HP University guidelines and directions of the state government.

1. Framework of Undergraduate Courses under New (U.G.C./H.P.U.) Choice Based Credit System:

Since H.P.U. has adopted the UGC pattern of curriculum for undergraduate courses under CBCS, the structure of UG degree is strictly in accordance with this pattern. Note:

- A) Students are directed to choose their DSC Subjects carefully since the First DSC Subject chosen by them will ipso-facto become their SEC Course/Subject from Second Year onwards. No change in DSC Courses/Subjects is permissible at a later stage.
- B) In addition to the two DSC Subjects each student will have to study Two Compulsory (Core/Language) Subjects, i.e, English and Hindi of 06 Credit Weightage each.
- C) The Students of B.A. 1st Year will also have to study One AECC Language Course/Paper from the two Language papers (English/Hindi), whereas Environment Science will be a Compulsory AECC Course/Paper for all.

2. ELIGIBILITY FOR THE DEGREE

2.1 A regular candidate shall have to undergo the prescribed course of study in a college affiliated to the H.P. University for a period not less than three academic years (and not more than five academic years), pass the examinations prescribed and fulfil such conditions that have been prescribed by HP University from time to time.

2.2 There shall be no private or other category of students and the candidates shall be eligible for degree through regular mode only.

2.3 For the degree (B.A./B.Com.) the student will have to accumulate a minimum of 132 successful credits (PASSED) of coursework over a minimum of three and maximum of five years from the date of admission.

2.4 Provided that not more than three attempts will be allowed to pass a course.

3. Choosing Study Courses Under Programme: -

3.1 At the time of admission in the First Year Degree Programme each student shall have to take four CORE COURSES including two compulsory language courses. In addition to these core courses, they shall have to study two Ability Enhancement Compulsory Courses (AECC), one of which will be Environmental Studies and one Hindi/ English communication course.

3.2 DSC - 1 and DSC - 2 once identified would not be changed unless the student quits a programme and joins a new programme.

3.3 B.A. with a particular subject would require a student to study Skill Enhancement Courses (SEC) of that subject in the II & III Year.

3.4 The Generic Elective required to be offered in the III Year by the student will be other than the two Discipline Specific Courses already offered by the student

4. Credits

The term 'credit' refers to the weightage given to a course, usually in terms of the number of instructional hours per week assigned to it. This explains why usually 'credit' is taken to mean 'Credit Hour'. The credit also determines the volume of course contents and delivery of programme such as lectures, tutorials, practical, assignments, etc.

For purpose of credit determination, the instructions are divided into three components: -

Lectures (L)- Classroom Lecture of One Hour Duration.

Tutorial (T)-Special, elaborate instruction on specific topics of one hour duration.

Practical (P)- Laboratory of field exercises in which the students must do experiments or other practical works of two-hour duration.

Each one of these components is considered as equal to one credit. One Lecture (L) as well as one Tutorial (T) is considered as one credit whereas one Practical (P) two hours is considered as one credit. So, in the form of symbols it can be written as C=L+T+P where C stands for credit.

5. Students' Course-wise Continuous Comprehensive Assessment (CCA) and Evaluation:

All courses that are undertaken by a student involve an evaluation system that has the following two components.

i. **Continuous Comprehensive Assessment (CCA)**: As per scheme of evaluation 30% of the final grade that the student gets in a course is through Internal Assessment.

ii) **Term End Examination (TEE)**: The remaining 70% of the final grade that the student gets in a course constitutes a Term End Examination.

5.1 Continuous Comprehensive Assessment (CCA): This would have the following components.

5.1.1 Classroom Attendance: Each student will have to attend a minimum of 75% Lectures / Tutorial/Practical. A student having less than 75% attendance will not be allowed to appear in the Term End Examination. Those having greater than 75% attendance (for those participating in co-curricular activities e.g., NSS, NCC, Sports, Youth Festival, RRC etc. 25% will be added to percent attendance) will be awarded CCA marks as follows: - 75% but <80%=1 marks: 80% but <85%= 2 marks, 85 but <90%= 3 marks, 90% but < 95%=4 marks, >95%=5 marks.

5.1.2 Class Test: There will be one class test for 5 marks after completion of at least 40% of syllabi of all courses opted by the student.

5.1.3 Mid-Term Test: There will also be one mid-term test for 10 Marks after completion of at least 75% of syllabi of all courses opted by the student.

5.1.4 Seminar / Assignment / Term Paper: The remaining 10 marks of the CCA will be awarded based on seminar/ Assignment / term paper, etc. that the teacher would give to students in respective disciplines.

5.2 Term End Examination (TEE): The remaining 70% of the final grade of the student in a course will be on the basis of Term End Examination (TEE) that will be of three hours duration and will be covering the whole syllabus of the course.

RULES FOR ADMISSION

1. The eligibility criteria for admission to BA/B. Com. in the 1st Year is strictly as per the latest ordinances/guidelines/calendar notified by the HP University/Government.

2. Candidates/parents/ guardians must read all instructions given in the prospectus carefully and submit application form complete in all respects online.

- 3. The candidate must fill up the particulars in the prescribed online admission form carefully.
- 4. Admission will be granted strictly on fulfilment of all eligibility conditions.
- 5. Any gap in the academic career of an applicant must be supported by a self-declared undertaking. In this case original Character-Certificate from the 1st class Magistrate/Gazetted Government Officer/Panchayat Pradhan, is a must.
- 6. A student must produce original documents at the time of counselling.

7. Rules of admission are subject to change as per HPU notification from time to time.

8. Candidates coming from Boards / Universities other than HP Board of School Education, Dharamshala/HPU, Shimla, must produce a migration certificate in original.

9. A Candidate having **compartment in 10+2 in any subject is not eligible** for seeking admission in B.A. I /B. *C*om. I Year.

10. Admission of a candidate is liable to be cancelled if he/she furnishes incomplete / false information or in case of concealment of facts. Disciplinary action will be taken against such candidates.

11. Girl students of H.P. seeking admission in any class must bring an attested copy of **H.P. Bonafide Certificate** to avail fee concession.

12. Principal of the college has the power to refuse or terminate the admission, if the conduct of a student during his or her stay in the college is unsatisfactory.

13. Students seeking exemption from tuition fee on the ground of special ability must attach the certificate issued by the medical board.

14. Only those candidates who have passed all the five papers including English from National Open School are eligible.

- 15. Candidates' ineligible for Admission:
 - A) A candidate having a compartment in any subject at 10+2 level.
 - B) A candidate who has been expelled or rusticated from any other institution.
 - C) A candidate who has passed Prabhakar examination without passing 10+2 examination.
- 16. Initially all the admission will be provisional (i.e., subject to approval by HPU).
- 17. A student can migrate from one college to another in accordance with the rules laid down by Himachal Pradesh University.
- 18. The admissions will be on the basis of merit.
- 19. The reservation of seats will be according to the HP University "120 points" roster given ahead.
- 20. Students may change their subjects up to 15th July 2025.

Eligibility for Admission in B.A./ B.Com. 1st Year:

1. Maximum age limit for admission to B.A./B.Com. First Year is 23 years for boys and 25 years for girls as on July 1, 2025(Chapter 3, 3.3.A of University Ordinance). For SC/ST candidates a relaxation of three years in the upper age limit is permissible. The Vice Chancellor of HPU may, in exceptional cases/ circumstances, to be recorded in writing, give relaxation in age up to a maximum of six months to any candidate. All such cases of age relaxation of up to six months may be granted admission provisionally by principal and a consolidated list of all such cases will be sent to the Vice Chancellor for necessary approval. Relaxation in upper age is also available to especially abled candidates.

2. Parents/Guardian's signatures are essential on the admission form failing which no admission will be entertained.

3. If the admission is cancelled by the University, the college will not be responsible.

4. Student with a record of misconduct/indulged in ragging in previous years will not be given admission in the current session.

Eligibility criteria for admission to B.A. Ist Year (Pass Course)

- Candidate must be clear pass at 10+2 level.
- Candidate who has passed all the five subjects including English from NOS is eligible to take admission.

Eligibility criteria for admission to B.Com. Ist Year (Pass Course)

- Candidate must have secured 45% marks in 10+2 in aggregate with Mathematics/Economics as one of the compulsory subjects at 10+2 level or 45% marks in aggregate for students from relevant vocational stream.
- A minimum percentage of 40% for those students who have passed 10+2 under commerce group.
- In case of girl students, the minimum percentage is 33% at 10+2 level(clear cut pass)

RESERVATION OF SEATS (Ordinance 3.14) 15%, 7.5% 3%, of the seats shall be reserved for S.C., S.T. & especially abled candidates respectively as per H.P. University 120 seats roster norms. This reservation will be applicable to those candidates who have passed their qualifying examination from H.P. Board of School Education or from School affiliated to any board but located within territorial Jurisdiction of Himachal Pradesh and must be bonafide of Himachal Pradesh. For reservation, the following roster will be followed: -

ZERO TOLERANCE TO RAGGING

Ragging is a criminal offence. It is strictly banned by the Supreme Court Orders. Ragging includes any type of physical or mental torture inflicted by any individual or group, either by words or by conduct, which creates an apprehension in the mind of the person that he/she cannot pursue his/her studies free from any mental disturbance or torture created thereby. Any person who aids or abets such an action shall also be guilty of such ragging. Ragging is strictly prohibited. If any student is found indulging in ragging directly or indirectly, the college authorities shall be obliged to initiate legal action & also expel the guilty student (s) from the college. On a written complaint from the newcomers, those ground indulging in ragging will be handed over to the police.

Any student found involved in ragging in any form whatsoever will be punished appropriately which may include:

- 1. Imprisonment, fine or both.
- 2. Suspension from the classes.
- 3 .Fine with public apology.
- 4. Withholding scholarship or other benefits.
- 5. Debarring from representation in events.
- 6. Suspension and expulsion from college.
- 7 .Legal proceeding under criminal law shall be initiated.
